

Minutes of a meeting of Stirchley and Brookside Parish Council Community and Environment Committee held at The Sambrook Centre on Tuesday 5th July 2022 at 7pm.

Public open session- Paul, Brian Edwards, Carol, Tracy, and Barry from Stirchley Allotments Association.

Paul asked the committee several questions:

- 1. Who will manage the site? This committee, officers from the parish council.
- 2. Will there be regular checks? Yes bimonthly.
- 3. Would there be new/updated leases issued? The committee are working on new agreements.
- 4. Would invoices be issued in December? Yes, it was our aim to do this.
- 5. Could plot numbers be aligned so they matched? Yes, this could be looked at.
- 6. Would the parish be getting a skip in autumn? Yes, we would aim to get a green skip.

The chair also stated that there would be a standing item on the agenda for this committee for the allotments and that they would also be looking at charges for plots.
