<p>Employment, Office, Trade or Profession Any employment, office, trade, profession or vocation carried out for profit or gain by the member or by their spouse or civil partner or by the person with whom the member is living as if they were spouses/civil partners.</p>		
<p>Sponsorship Any payment or provision of any other financial benefit (other than from the Council) made to the member during the 12 month period ending on the latest date referred to in paragraph 6 in the code of conduct for expenses incurred by them in carrying out their duties as a member, or towards their election expenses. <p>Licences Any licence (alone or jointly with others) held by the member or his/her spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners to occupy land in the area of the Council for a month or longer.</p>	 N/A
